Kalupur railway station faces increased traffic, drives, obstructs parking and rickshaw pullers who pick up more passengers

There has been a lot of traffic outside the Kalupur railway station for quite some time now. A note has been taken about this traffic to the higher authorities. Yesterday (August 18) a special drive for rickshaws was held outside the railway station by the traffic police. In which action has been taken against rickshaw drivers parked obstructingly and rickshaw pullers who seat more passengers than the capacity. The traffic police has detained as many as 66 rickshaws in eight hours. Still

People of Fatepura's Nani Dheli forced to cross river for last rites road not constructed despite repeated representations



Dahod, In Nani Dhadeli village of Fatepura taluka of Dahod district, people are forced to go through the flow of river water to the crematorium for the last rites due to the lack of construction of a road from the village to the crematorium in Bhedi Paliva. In spite of repeated representations by the villagers to the concerned authorities regarding the introduction of the road, there is a lot of outrage among the villagers due to the nonconstruction of the road till today. Dahod district is a district with tribal majority, the government allocates millions and crores of grants for the happiness and convenience of the people in the tribal area. Even in Dahod district, the government has allocated crores of grants to provide basic facilities like roads,

water, sanitation etc. but there are many villages in Dahod district in which the system is proving to be lax in providing basic facilities to the people. Then a similar scene was seen in Bhedi Paliya at Nanidheli village of Fatepura. When a person dies in this village, people have to cross the river to reach the crematorium during their final journey, especially during the monsoon season. People are facing great difficulty due to lack of road to reach the crematorium. There is also a lot of anger among the people as the road to the crematorium is not built by the system in the village. Despite repeated written and verbal representations by the villagers to the administrative system and the village panchayat, no road has been constructed in this village so far.

The marriage was not approved by Chandni's family and Janish's family was repeatedly pressured by her father and family to hand Chandni back. However, Janish and his family did not hand over possession of Chandni to him.
